

Preventive Care Services Guidelines for Clinicians

Samaritan Health Plans (SHP) reimburses in-network/contracted clinicians for services rendered below as preventive benefits with no cost share to the member. If coded as indicated in the model, members pay nothing for the service. Clinicians may also append Modifier 33 to indicate a preventive service as appropriate in accordance with billing standards. Preventive services should be provided following the frequency limits outlined in the United States Preventive Services Task Force (USPSTF), Bright Futures or Health Resources & Services Administration (HRSA) guidelines.
